AGATHA HOFF: "Judge*Hoff, Jesus Loves You, But the Rest of Us Think You're an A**Hole!:

Tales from my 20 years as a San Francisco Court Commissioner

Wednesday, October 21, 2012 at 3pm United Irish Cultural Center

Writer **Agatha Hoff** will read excerpts from her latest book, "Judge*Hoff, Jesus Loves You, But the Rest of Us Think You're an A*Hole!." She chronicles her life as a San Francisco

Commissioner with a series of humorous and often poignant vignettes. Commissioner Hoff vividly captures the unique atmosphere of the Hall of Justice. If you have ever worked at the Hall of Justice, contested a ticket or even like watching Judge Judy, you will enjoy her stories.

Agatha Hoff started in poverty law where clients often abandoned her for a "real lawyer" (meaning someone they paid). When she became a real lawyer, her personal injury clients termed her practice "the armpit of the law". When she was appointed a court commissioner, her favorite moniker was uttered by an angry litigant in traffic court, calling her a "fascist terrorist cross-dressed in the cloak of justice". When at last a British tourist called her "Your Worship," Agatha thought she'd retire before it went to her head. She celebrated her retirement by going skydiving before embarking on a new career as an author. In her first novel, "Burning Horses, a Hungarian Life Turned Upside Down", she wades boldly into an ocean of memory and storytelling about World War II, the Holocaust and its impact on the life of a Catholic of Jewish ancestry. The author describes the violent destruction of a city, a country, a culture and a great love in this story of one courageous woman's life lived amid agonizing change.






